#### MESSAGE FROM THE CHAIRMAN – John A. Ross

Our water quality monitoring program continues to add to our understanding of the river, allowing us to see trends, thus giving us the ability to tailor our projects to the needs of the watershed. A large fire west of Milk River last fall, while devastating to the landowners, became an opportunity to study the recovery of the native prairie. We will be sampling the water to determine what, if any, changes in run-off and water quality from the site into the river will occur without the protection of the grass. We had the great honor to host the WPAC Summit in September. We were treated to some very informative guest speakers; I continue to learn from these great people. Our second State of the Watershed report is nearing completion and should be available later this spring. It's hard to believe that it's been 5 years since the last one, but this one should be bigger and better expanding to include parts of the watershed outside of our province containing input from Montana and Saskatchewan. We've also been working very hard on the Integrated Watershed Management Plan, which should be completed this fall. This will be our community's guide for the future.

The Microbial Source Tracking project was initiated, with samples being collected throughout the summer and the DNA being analyzed. Initial reports are extremely interesting and I believe the results will be not only surprising, but also change the way in which we view water quality within not only our watershed, but potentially all watersheds.

Many thanks go out to the directors and especially our staff, Tim Romanow, Mary Lupwayi, and Sandi Riemersma. We continue to push forward and without their dedication we couldn't achieve what we did this year; and as one of the directors said, they make me look good.

# Water Supply and Management Team - Don Welsh, Chairman

 Participated in the Alberta-Montana Water Management Initiative, a joint cross-border Council formed to address water sharing and management for the Milk River

# Research and Monitoring Team - Will Lindeman, Chairman

#### MiRTAP: Milk River Transboundary Aquifer Project

- Partnered with Geological Survey of Canada to manage a Milk River Transboundary Aquifer Program (MiRTAP) focused on the 3-dimensional model development of the Milk River Aquifer
- Isotopic analysis of groundwater samples used to determine the age of groundwater.
- Measurement of groundwater levels in the wells on the Milk River Aquifer to reflect the current state of the groundwater conditions..

## **Surface Water Quality Monitoring Program**

 Completed 7<sup>th</sup> year of surface water quality monitoring on the Milk River, including third year of monitoring on the Eastern Tributaries

# Impact of the Milk River fire on grassland recovery and watershed health

 Partnered with University of Alberta to study the impact of the Milk River fire on grassland recovery and watershed health as well as any potential human health concerns that could result from the fire erosion or runoff

#### Milk River Microbial Source Tracking Project

Worked on Microbial source tracking project in partnership with Agriculture and Rural Development,
 Environment and Sustainable Resource Development, Alberta Health Services and University of Regina to
 identify and quantify the main sources of fecal contamination in the Milk River. Given that water quality
 guidelines are driven by E. coli concentrations, this study will utilize E. coli fingerprinting as a microbial
 source tracking method

# Integrated Watershed Management Plan (IWMP) Team - Ken Miller, Chairman

- Prepared the IWMP which makes recommendations to decision making authorities, natural resource
  managers, users, and residents regarding the management of land and water resources in the watershed
  that reflect the communities desired watershed outcomes
- The Milk River IWMP will link the issues of groundwater and surface water quality/quantity, biodiversity, landuse, and stewardship with the watershed's economic and social priorities.

# Executive Director's Report - Tim Romanow

2012-2013 has been an eventful year for the MRWCC. Our watershed hosted the 2012 Watershed Planning and Advisory Council Summit where we showcased challenges, opportunities, and incredible messages of stewardship within our watershed. Representatives from across the province's 11 major watersheds attended the summit, many of which had never been to our area before. Work on our new Transboundary State of the Watershed (SOW) report has been very rewarding; building new partnerships across our watershed boundaries has been a model for other watersheds in Alberta.
